



ROAD TRAFFIC REGULATION ACT 1984: SECTION 16A
THE COUNTY OF POWYS
(VARIOUS ROADS NEAR YSTRADFELLTE, TRECASTLE AND CRAI)
(DRAGON RIDE CYCLE EVENT)
(TEMPORARY PROHIBITION OF DRIVING) ORDER 202

WHEREAS POWYS COUNTY COUNCIL is empowered by Section 16A of the Road Traffic Regulation Act 1984 ('The Act') from time to time to make Orders for the lengths of road specified in the Schedule hereto to be observed by pedestrian, equestrian and vehicular traffic and for preventing the obstruction of streets in all times of public processions, rejoicings or illuminations and in any case when the streets are thronged or liable to be obstructed.

AND WHEREAS on the 14th June 2026 it is proposed to hold a cycle event known as the Dragon Ride in the County of Powys

AND WHEREAS after consulting with the police and the fire service it is concluded that in order that the said Event may take place it is necessary to prohibit driving along those lengths of road in the said County of Powys described in column 1 of Schedule I hereto on those days and between those hours as appear in column 2 of the said Schedule

NOW THEREFORE the Council in pursuance of the powers in that behalf conferred by the said Section 16A of the Act hereby make the following Order:-

1 (a) Subject to the proviso hereto that length of road appearing in column (1) of the Schedule hereto shall be closed to vehicles of all classes and description during the period of closure specified in column (2) of the said Schedule and no such vehicle as aforesaid shall enter wait leave or pass along or over the said streets during the said period of closure

(b) Provided that this Order shall not operate so as to prevent:-

(i) vehicles belonging to the organisers of the said Event or other persons authorised by them from entering waiting leaving or passing along or over the streets specified in column (1) of the Schedule hereto during the said period so far as it is reasonably necessary in connection with the said Event.

(ii) ambulances and vehicles used by or on behalf of doctors the police the fire service and statutory undertakers from entering waiting leaving or passing along or over any of the streets appearing in column (1) of the Schedule hereto during the said period of closure in the event of an emergency

2. This Order may be cited as The County of Powys (Various Roads near Ystradfellte and Crai) (Dragon Ride Cycle Event) (Temporary Prohibition of Driving) Order 20

3. The plans annexed hereto are for the purposes of identification only

SCHEDULE

(1)

Lengths of Road

County Classified Road Number C0180

That length which extends from its junction with the C0181 at a point 500 metres east of Heol Senni and extending for a distance of approximately 10.70 kilometres in a southerly direction to its junction with the C0182, near a property known as The Vicarage, Ystradfellte.

(County Classified Road Numbers C0168 & C0178)

That length of the C0168 which extends from its junction with the A4067 in Crai for a distance of approximately 5.6kms in a north-westerly direction and then joining the C0178 near Ynys-marchog and continuing for a distance of 500 metres in a northerly direction to its junction with the A40 trunk road at Trecastle, adjacent to the Castle Inn.

County Classified Road Number A4067

The lay-by on the north side of the carriageway 1.2 kilometres south-west of the U0335 adjacent to Fan Cottage, Crai and which extends for a distance of approximately 122 metres

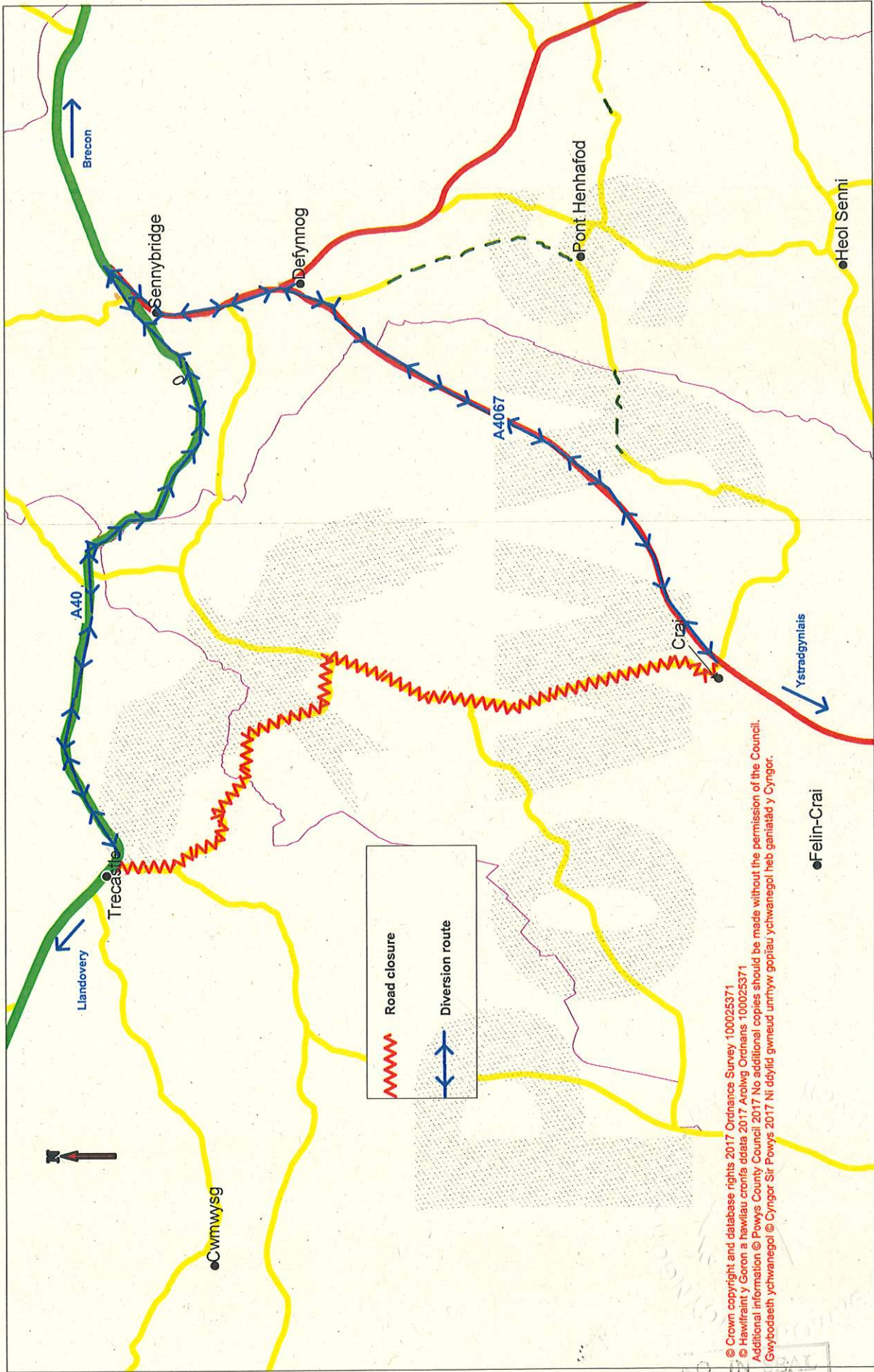

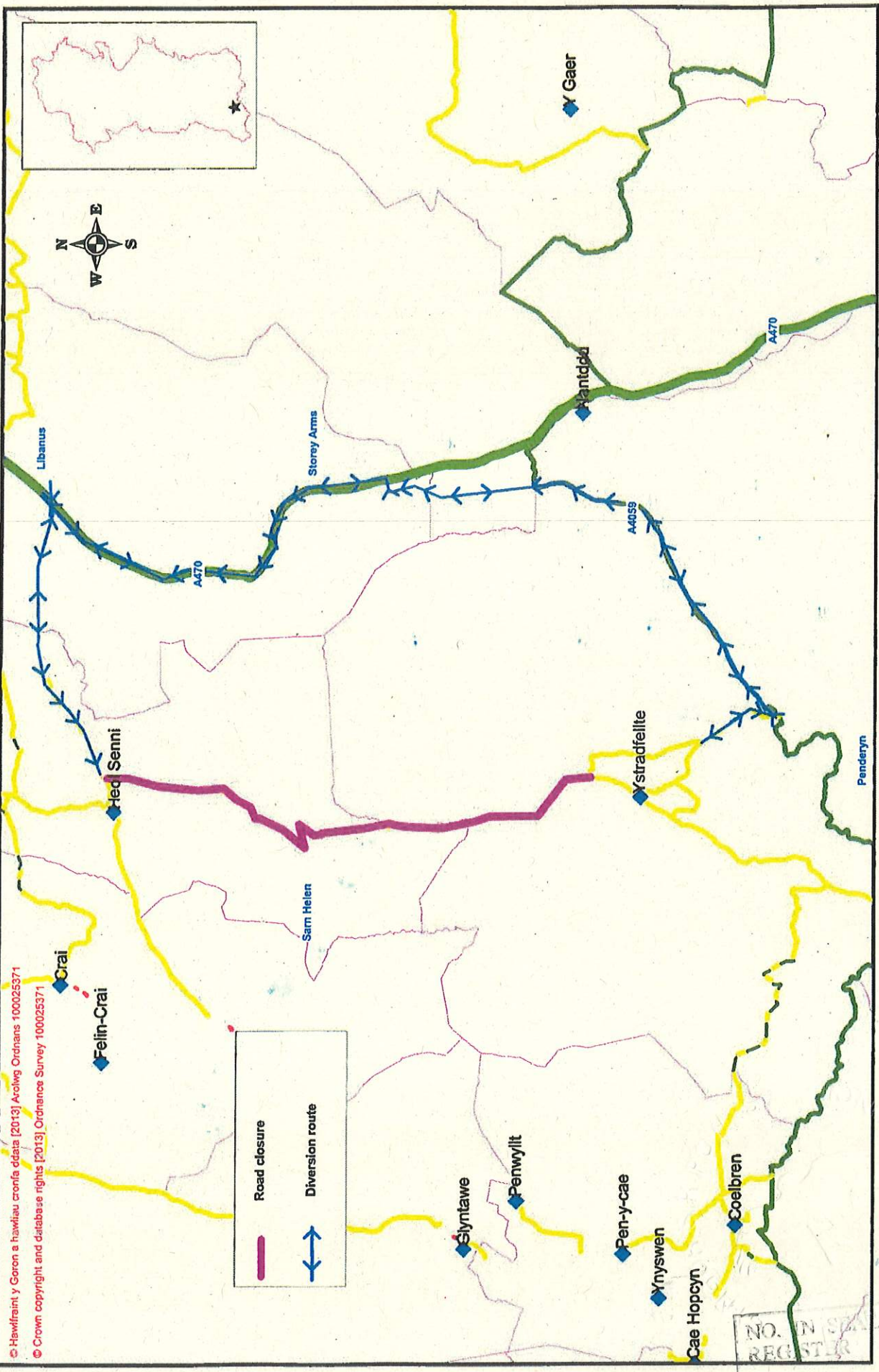
